new hire reporting texas workforce commission Aug 14 2021 new hire reporting is mandated by federal law under the personal responsibility and work opportunity reconciliation act of 1996 and requires employers to report new hires and rehires no later than 20 calendar days after the hire date if you report electronically you must report 12 to 16 days apart which is about twice a month
